

## - CDL/IDs With an Old Address or PO Boxes -

Validating Your ID - Federal "Know Your Customer"

Federal regulations require that all firearm purchasers have a valid, government-issued ID.

\*\*\*\*\*This document must have:\*\*\*\*\*

- Buyer's Picture
- Buyer's Full Name
- Buyer's Residential Address (where the buyer actually lives - PO Boxes are NOT allowed) -- See Note Below --
- Buyer's Date of Birth

**CA requires the use of a CDL, CID Card or Military ID with local Station Orders to buy a firearm. As such, these are the only documents that we will accept to meet the above requirements.**

- Note -

**If your CDL/CID does NOT have your current residential address,**  
You must provide an additional **Government-Issued Document** to meet the above regulations.

\*\*\*\*\*This document must have:\*\*\*\*\*

- Issuing Government Agency's Information
- Be valid: not expired or before its period of validity. (It's okay if the document does not have a period of validity.)
- Buyer's Full Name (must match ID and have any Suffixes: Jr., II, III & Sr.)
- Buyer's Current Residential Address
- Be printed by the government agency that issued it and mailed to you
- Be printed out in a government office if hand picked up
- Be recognized/known by our facility or validated by us with the government (Monday - Friday)
